Limits and fees - The following fees may be assessed against your account and the following transaction limitations, if any, apply to your account:

Check printing

Fee depends on style and quantity of check ordered.

Counter checks

\$2.00 per 4 checks,
waived if check order
placed through bank

Stop Payments- each

\$25.00

Returned Item Fee (NSF) - each

\$25.00

Daily maximum \$100.

Overdraft Fee - each

\$25.00

Daily maximum \$100. The fee is waived if the total account overdraft is less than \$10.00 or the item is less than \$10.00.

The categories of transactions for which an overdraft fee may be imposed are those by any of the following means: check, in person withdrawal, ATM withdrawal, or other electronic means.

Overdraft for more than seven consecutive days

\$5.00 per business day

ATM and Everyday Check Card Overdrafts

Dormant account fee

Savings accounts are considered dormant if for two years no withdrawals or deposits, other than credited interest, have been made to the account. The savings dormant account fee is \$6.00 per quarter
